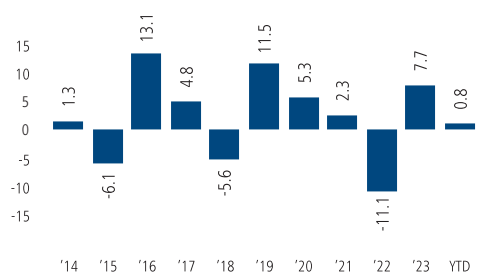

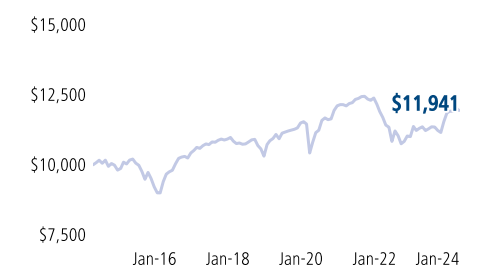

### Why Invest in this fund?
